- All activities carried out within the scope of this Policy in cooperation with Suppliers are fully compliant with the recommendations and guidelines of the PCC Group in the area of occupational health and safety.
- All activities arising from the provisions of this Policy are aligned with the strategy and values of the PCC Group and are consistent with the idea of sustainable purchasing.

### **OBJECTIVES OF SUSTAINABLE PURCHASING POLICY**

- Strive to increase the value of the organization by improving productivity, making sustainable investments and implementing innovative products, system and technology innovations..
- Maintain effective communication with Suppliers, based on mutual respect for the culture and values of all parties involved.
- Strive to balance the economic viability of the business with the broader public interest and responsible management of purchasing processes.
- → Design, manufacture and launch products based on raw materials that meet high sustainability standards.
- Encouraging projects and investments, in particular those aimed at sustainable production and consumption.
- Oconstant cooperation with Suppliers based on raising standards of sustainable development in the area of production, transport, maintenance, employee safety, process safety and all other areas where we deal with purchasing processes.

- Honesty in business suppliers of the PCC Group do not practice or tolerate any form of corruption, extortion or embezzlement.
- To apply the principles of fair competition, confidentiality and protection of information.
- To ensure the safety and health of employees, including subcontractors in the workplace and ensure the safety and quality of products and services provided.
- To identify and assess risks related to the safety of people, the environment and the offered products and services, and implement actions to minimize the risks.
- To inform PCC Group companies of any hazards or risks associated with the products and services provided.
- Continuous and effective reduction of negative impact on the environment.
- Respect for human rights.
- To combat discrimination based on nationality, social origin, gender, age, sexual orientation, religion, culture and other expressions of diversity.
- To train and improve employee qualifications.
- To maintain complete and transparent business records.
- To respect the principles related to conflict minerals and exercise due diligence in the control of supply chains of materials for the manufacture of which 3TG is used.
